


## A Message from the Chair of NAFSA Region V

## **NAFSA Region Updates 2020**

Below are some updates on what has been happening in Region V during 2020!

## **Advocacy**

With all of the policy updates, institutional pivots, global crises and the U.S. election already underway, advocacy remains an indispensable value and high priority in NAFSA Region V. Sadly, Advocacy Day 2020 was canceled due to the Coronavirus, but prior to the cancellation, Region V expected a fantastic turnout. We had 25 Region Vers registered to attend Advocacy Day (11 from Illinois, 7 from Michigan, and 7 from Wisconsin). Region V awarded grants to:

In addition to these regional awards, members from Illinois, Michigan and Wisconsin were able to register with support from their state organizations. Wisconsin, in particular, remains one of the key states in which NAFSA is devoting the association's support and attention to advance our public policy agenda. To that end, Early Bird participation rates were extended for Fivers from key districts in Wisconsin, and, with the help of Region V and WAIE leaders, were able to reach out to members working for institutions in those districts to encourage additional participation from Wisconsin advocates. In addition, three Region Vers were interviewed about their advocacy work in the most recent issue of International Educator.

With the election already underway, Region V is partnering with our friends in Region III to host a webinar on Friday, October 23<sup>rd</sup> at 1pm Central, 2pm Eastern, titled, *Home Stretch: International Education and the 2020 Election.* Check it out on Region V Facebook or Twitter, or navigate <a href="here to register to the event">here to register to the event</a>. # **NAFSA Region V Awards**

New Award! - Diversity, Equity & Inclusion in International Education Award - Hernando Sevilla-Garcia Hernando has worked tirelessly to advance opportunities for study abroad at Hispanic-Serving Institutions. Among his many accomplishments, Hernando has presented on advancing diversity in study abroad at numerous conferences, co-authored Diversity Abroad's LatinX Student's Guide, and launched Tu Mundo, an outreach initiative designed to increase participation in study and internships abroad for students at HSI's. He is currently working toward the launch of a faculty-led service-learning study abroad opportunity for HSI students in Chicago. Hernando's contributions have been, and continue to be, very valuable to our field and we are honored to award him the inaugural Diversity, Equity & Inclusion in International Education Award in 2020.

## Patti Jones Award for Outstanding Leadership in Region V- Kristy Aoki

Kristy's contributions to the region and the field are numerous. Kristy has served Region V in various roles including the chair stream and conference planner for 2019. Additionally, Kristy has also served at state and national levels within the Wisconsin Association of International Educators and as a NAFSA Regional Affairs Committee Chair. Kristy's work and support is valued at local and national levels and we are excited to honor her with this award in 2020.

#### **Budget**

NAFSA Region V remains in a strong financial position which is the result of thoughtful and sustainable financial stewardship over the years. As of October 14, 2020, NAFSA Region V has a current operating balance of \$138,458, an investment account balance of \$98,930, with a total balance of \$237,388. While this amount may seem high, it is important for an organization such as ours to maintain strong financial standing given our multi-year financial commitments, such as our regional conference.

This strong financial position also allowed us to absorb the cancellation of the in-person regional conference for 2020. Unfortunately, the pandemic did not provide sufficient justification to cancel existing conference contracts, so with the assistance of NAFSA Nationals we were able to negotiate a much lower expenditure for the cancelation of the in-person event. Despite the difficulties this year, we remain on solid financial footing as we prepare for next year's bi-regional conference with Region IV in Schaumburg, Illinois.



In addition to cancellation costs, NAFSA Region V was able to honor Advocacy Day travel awards for our membership (covering reimbursements for cancel travel plans of our awardees), fund NAFSA Region V Academy Coaches and class, offer several 2020 Regional conference awards, and organize our virtual conference at no cost to attendees!

#### 2020 Conference

We are pleased with our ability to offer this free virtual event in 2020. This <u>Digital Publication</u> compiled by NAFSA Region V Exhibitor and Sponsor Coordinator, Katerina Roskina, serves as a sort of virtual expo hall, allowing you to learn about and connect with important members of our region and field!
